As a result of this process, together, we created a vision statement and a mission statement that we can use to drive us forward. These are:

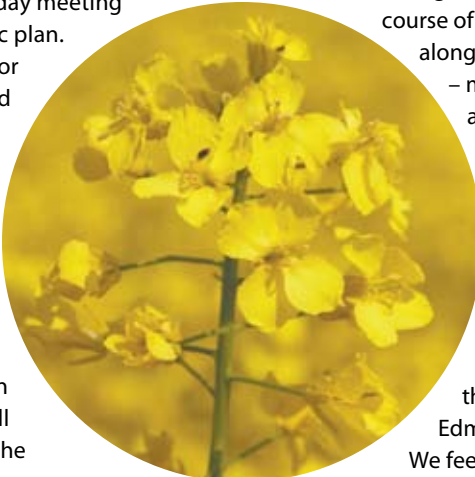
**VISION STATEMENT:**

## YOUR PROVINCIAL ASSOCIATION TOGETHER WITH THE MANAGERS ASSOCIATION ANNOUNCES A 2ND SCHOLARSHIP AVAILABLE TO DEPENDENTS OF ALL PERMANENT EMPLOYEES!

SCHOLARSHIP CRITERIA INCLUDES:

1. Scholarship to be limited to the dependents of permanent employees (employed no less than 1 year) of an affiliated Seed Cleaning Plant excluding managers.
2. Students must be in full time attendance at any accredited post secondary institutions.
3. Scholarship in the amount of one thousand dollars (\$1,000.00) to be awarded annually. The Association of Alberta Co-op Seed Cleaning Plants Ltd. & Managers Association of Alberta Co-op Seed Cleaning Plants Ltd. each to fund 50% of the \$1,000.00 scholarship.
4. Scholarship to be awarded first on the basis of need regardless of field of study.
5. Scholarship to be awarded secondly on field of study (Agriculture).
6. Scholarship to be awarded thirdly on basis of academic standing.
7. If in any year there are no applications from first year students, the selection committee may grant the scholarship to second, third, or fourth year students.
8. Applications must be in the hands of the Board of Directors by the 30th day of August of the year that the students are attending school.
9. An appointed committee is to act as the Scholarship Board.
10. If one of the Board members has a dependant applying for the Scholarship, they must excuse themselves from the Scholarship Board for that year.
11. Funds for the Scholarship Awards are to be taken from the general revenue of the Association of the Alberta Coop Seed Cleaning Plants and Managers Association.
12. Recipients of the scholarship will be presented at the Annual General Meeting to be held in January of the following year.

## SEED QUALITY UPDATE – FALL 2008

Early indicators are pointing towards a seed crop which has strong germination capacity, but seed quality is pressured by disease.

The average germination percentage of cereals and canola are approaching the mid-90% range, and peas are balancing around 90%. Wheat and barley germination percentage is on par with last year's testing to date. There is a marked improvement in oat germination in 2008, which is likely contributed to this year's improved late harvest conditions in comparison to 2007. Pea germinations, on the other hand, are trending lower by a few percentage points, but the average may be skewed by a few extremely poor results. Stay tuned as more results become available.

## HEALTH SPENDING ACCOUNTS

At the October BOD meeting Doug Sample with Morneau Sobeco presented the BOD an option that may enhance an employee's health & dental benefits plan. They have an agreement in place with an insurer that would allow individual seed plants to implement health spending accounts for their employees at their discretion. In other words, this would not require all plants to participate – it is the decision of that individual plant if they want to offer this to their employees or not.

Legislation requires that health spending accounts are to be 100% solely funded by the employer – an employee cannot make financial contributions to this account. An administration fee of 12% (to be paid by employer) will also apply to funds that the employee actually uses from their health spending account. These funds can then be used for health and dental expenses which are not covered under the current group benefits plan or payment of expenses over the insured maximums. Examples of eligible medical expenses include:

- > Vision care expenses such as glasses and eye exams
- > Elective procedures including adult orthodontics and cosmetic surgery

The headline this year is DISEASE! Ergot levels are high to alarming in some regions, plus widespread across western Canada. This will likely cause difficulties during seed processing, as the success of removing ergot bodies is a function of quantity, as well as size of the ergot bodies. To date, BioVision has tested a similar number of wheat samples for *Fusarium graminearum* to 2007. Unfortunately, the number of wheat samples that have tested positive for the presence of *Fusarium graminearum* in Alberta has climbed significantly from 9 samples submitted in the fall of 2007 to 28 samples submitted in the fall of 2008. Do keep in mind that this data set represents testing in September and October only, and a wider data pool will be available as the year progresses.

- > Prescribed lifestyle benefit expenses such as nutritional supplements and fertility drugs
- > Services of paramedical practitioners including chiropractors, acupuncturists, optometrists, physiotherapists, etc.
- > Private medical plan premiums

In the previous newsletter we had requested feedback from those plants currently using Manulife benefits to indicate if they wish to see Vision & Orthodontic coverage added to their benefits plan. Only 1/3 of the plants currently using Manulife responded with overwhelming majority that they **DO NOT** wish to see Vision & Orthodontics added on! Both are expensive additions to the plan and not every participant needs these services. Whereas a Health spending account may certainly offer flexibility to each individual as to which services they require and need extra funding for and **NOT** all plants are required to participate in order to have this "coverage" available.

In the summer of 1957, Adley Carter, George Sayle, Jim Bushel, Laverne Sheehan, Mike Duda, Lee Warren and Bertle Liland got together and applied for a grant to build a Seed Plant.

Construction got started and in the summer of 1958, Lee Warren cut the ribbon in the opening ceremonies for the Sexsmith Co-op Seed Cleaning Plant!

Time eventually took its toll on the building and it was torn down in August 1984, but not before a new building was built and officially opened on June 28, 1984!



## SEED PROTECTANT APPLICATOR CONTINUING EDUCATION CREDITS

Facility Audits have been developed to allow Seed Protectant Pesticide Applicators to obtain Recertification Credits through a Continuing Education Program by participating in pesticide product manufacturer training and audit of their or their employer's seed treatment facilities.

To qualify for pesticide applicator recertification credits, Seed Protectant Pesticide Applicators must be employed by the facility being audited, must attend the pesticide product training provided by the auditor and must participate in the entire facility audit. A maximum of 3 credits/audit/applicator (2 credits in the Application Technology concept and 1 credit in the Health and Safety concept) will be granted if all conditions are met. A maximum of 6-credits/certification period/applicator will be allowed for each applicator.

At a recent meeting of the Seed Protection Applicator Licensing committee, a motion was brought forward to increase the number of credits an applicator can obtain by going through an audit. An update of the outcome of this initiative will be made as detail become available.

All applicators are encouraged to go through the audit process, as it is a great tool to assess seed treatment operations, and may have positive spin-off effects with insurance companies and other agencies. Most Auditors approach the audit as involving the applicator to give his/her evaluation of the seed treatment process, hence the audit is a great benchmarking tool. To proceed with a facility audit, the applicator should book an appointment with an Auditor. For Bayer CropScience, Monica Klaas is an approved auditor and can be reached at 403-625-7027.

## REMOVAL OF KVD – WHAT NOW?

At Seed & Crop Tech Workshop we were fortunate to have Randy Dennis, Chief Grain Inspector with the Canadian Grain Commission provide an update on the process after the Removal of KVD (Kernel Visual Distinguishability) within Western Canada's Grain Handling System. Below you will find key points that grain producers (your customers) need to know when they deliver wheat to their elevator.

### What changed on August 1, 2008?

- A declaration system, as part of a quality management system for western Canadian wheat was introduced.
- When you deliver wheat, you will have to sign a Declaration of eligibility for the class form. By signing the form, you are

attesting that the wheat you are delivering is eligible for a specific class of western Canadian wheat.

- A ninth wheat class has been introduced – Canada Western General Purpose – with disease resistance and agronomic criteria, but with limited quality requirements.

### Why introduce declarations?

On February 11, 2008, Kernel Visual Distinguishability was removed as a registration requirement for all western Canadian wheat classes. This means varieties put forward for registration can look like each other and the existing wheat classes, but they will still have to meet all other registration requirements for quality, disease resistance and agronomics.

### How will these changes affect you?

They will affect how you select your seed, your after-harvest storage practices and grain delivery.

### But first, what are classes and varieties?

There are nine western Canadian wheat classes. Varieties are developed by plant breeders for each class.

### What's the concern about eligible varieties?

The Canadian Grain Commission (CGC) has variety designation lists for Canadian wheat. The lists include all the western Canadian wheat classes and all the varieties that are eligible for each class. The grain industry uses the lists to keep ineligible varieties from undermining the quality of grain shipments and possibly causing problems for end users. The primary elevator operator will grade your wheat delivery according to your declaration to class.

### Know your seed

Only varieties on the variety designation lists are eligible to be graded as one of the eight classes of milling wheat. If you grow a variety that is not listed on the variety designation lists or if you do not declare that it is eligible for a specific class for which you are requesting payment, when you deliver it will only be eligible for the Canada feed class or the lowest grade of amber durum.

**The best way to know the variety of your wheat at delivery is to know your seed before planting, by doing one or both of the following:**

- Have your old or common seed tested at a private lab before seeding.
- Purchase certified seed.

### Maintain careful records of your harvest

For most producers this simply means continuing good operating practices. For others, it means establishing tighter quality management controls.

- Before storing grain, bins should be empty and clean.
- Put only one class of wheat in each bin.
- Maintain careful records to keep track of the wheat in each bin.
- If you are not sure of the wheat class in a bin, have the wheat tested at a private lab before selling it.

If you have someone hauling grain for you:

- Provide clear instructions to the transporter about which bins to load from.
- Be present at the time of loading to direct the person hauling your grain.

### Declare your wheat at delivery

On August 1, 2008, the Canadian grain industry introduced a declaration system for western Canadian wheat. Annually, at every elevator where you deliver wheat, you will be required to complete the Declaration of eligibility for the class form confirming that the wheat you will deliver is eligible for a specific western Canadian wheat class. Be ready to verbally declare the class of wheat you are delivering for each load.

If you have someone hauling grain for you, you are responsible for ensuring that:

- You have signed a declaration form at that elevator prior to delivery; and
- The transporter is able to identify the class at the time of delivery.

The same process applies to producer cars. You are responsible for signing the form and sending it to the administrator of your producer car.

The elevator receiving your wheat will keep samples for random testing and monitoring.

### We all have a part to play

Canada's assurance of grain quality will not change with the new declaration system for western Canadian wheat. As partners in the grain sector, we are all committed to working together – producers, grain handlers, marketers and government.

You will receive, shortly in the mail, a list of the 9 western Canada wheat classes and the varieties that are eligible for each class. If any of your customers have any concerns, or questions with whether a variety is eligible or not, this list will be an excellent resource to refer to. The Canadian Grain Commission will provide updates in a timely matter which we will continue to make available to our member plants. There is a concern in the industry of the possible lack of communication to grain producers of newly registered varieties, de registered varieties (when and why) and unregistered varieties. What a great opportunity for plants and the association to work with the industry and provide timely information to your shareholders!

**As Seed Cleaning Plants, an important message for you to send to your customers is to make sure they Know what Seed they are Planting!**

- Communicate the value of Certified Seed.
- Stress how essential it is to collect representative grain samples at harvest and upon delivery. Producers are liable for the product they deliver to a grain elevator – if what they deliver is not what they had declared it to be, they may be responsible for any potential damages or losses!
- If a grain producer is uncertain of what variety they may have, you may recommend to have a sample sent away for varietal testing. Holly Gelech with BioVision gives a detailed explanation of what testing is available for this purpose (immediately following this article).

## RAXIL PRODUCT LINE UPDATE

The label expansion to include additional cereal crops for **Raxil® MD** has been approved! Full registration on Barley and Oats is expected in January. Raxil MD is currently registered on wheat, and has gained a reputation of being easy to handle, non dusty, and is fully compatible with JUMPSTART®.

The registration of **Raxil® WW**, a new seed treatment product positioned to control wireworms in cereal crops has not been granted, hence, Bayer is not planning having this product ready for the 2009 season. Results from the 2008 Federal Research Permit program which allows limited use of new, unregistered products were very successful, much anticipation surrounding the release of this exciting new product.

Last, but not least, **Trilex® AL** is still in the development phase, and could possibly have a limited release to commercial applicators for the 2009 season.

Any developments regarding any of the new products will be communicated to the marketplace as soon as details become available.

## VARIETAL PURITY

Varietal Purity is the analysis of a grain or seed sample through molecular methods to determine the varietal composition. Used by the grain industry for years to ensure export requirements are maintained, knowing seed origin has become paramount to producers and seed growers due to the creation of the grain declaration system, which was prompted by the removal of Kernel Visual Distinguishability (KVD) as a varietal registration requirement.

Each seed variety has its own unique fingerprint that can be analyzed and compared to standards. The standards are composed of seed varieties that are registered and un-registered for sale in Canada, and are hosted within laboratory archives, also referred to as a "Library". There are numerous technologies available to evaluate varietal composition, which can vary greatly in turnaround time and cost. BioVision Seed Labs offer varietal purity testing using the below methods:

### **Polyacrylamide Gel Electrophoresis (Acid-PAGE) and Isoelectric Focusing (IEF)**

Electrophoresis is a technique which separates proteins through a gel media according to their electrophoretic charge (IEF method) or size and charge (Acid-PAGE method). The protein separation from ground kernels and preceding staining procedure produces a banding pattern on the gel matrix which is compared to the standard Library for determination of varietal purity. The below section outlines the crop species that can be evaluated through electrophoresis and the volume of seeds used for the analysis.

#### **Crop type:**

*IEF method:* Wheat (Durum), Oat, Peas  
*Acid-PAGE method:* Wheat (All remaining Classes)

#### **Sample Size:**

*IEF method:* 48 individual seeds  
*Acid-PAGE method:* 96 individual seeds

To increase the statistical accuracy of the test, clients may elect to increase the sample size.

### **High Performance Liquid Chromatography (HPLC)**

Similar to electrophoresis, HPLC is also a protein based test, but there are significant differences between the two types of methods in speed, equipment and sample size. HPLC does not analyze individual seeds, but analyzes a bulk grind of the sample submitted. Once the kernels are ground, proteins are extracted with reagents, then the solution is pushed by high pressure through a densely packed column and separated based on their interactions with the materials inside the column. A chromatogram, which is a series of peaks and valley, is created indicating the presence & absence of proteins. This chromatogram is compared to the standards within BioVision's Library for determination of varietal purity. Typically this method is useful in the evaluation of 2 row malt barley varieties, but 6 row malt barley varieties present evaluation difficulties due to their inherent genetic similarities.

#### **Crop type:**

*HPLC method:* 2-row malt Barley, 6-row malt Barley (limited)

#### **Sample Size:**

*HPLC method:* 50 gram bulk grind

The varietal purity results are reported to the client as a breakdown by percentage of variety/varieties present in a sample. When submitting a sample, please follow the below guidelines:

- > Submit 250 grams of seed for testing.
- > Indicate the suspected variety on the sample bag.


